The Club is maintained by its members. Fees do not cover the cost of this maintenance, and support is required from all members.

Notes:

- [1] Half rates commence 1st Sept.
- [2] Duo membership: Two adults living at the same address.
- [3] Family membership: Parents with their children who are under 21 (on 1st Jan) and living at home.
- [4] Junior membership: Less than 18 (on 1st Jan), accompanied by a parent or guardian and this form signed by a parent/guardian
- [5] Student membership runs for 10 weeks starting 1st July and includes the use of Club boats.

The Committee reserves the right to refuse applications and return subscriptions without prejudice or stating the reasons for so doing.
